

CITY OF DARLINGTON COUNCIL PROCEEDINGS
AUGUST 15, 2017

The meeting was called to order by Mayor Dave Breunig at 7:13 PM. The Pledge of Allegiance was then recited. Present at roll call were: John Sonsalla, Don Osterday, Steve Pickett and Erin Gallagher. Excused absence: Dave Gough and Cindy Corley. Also present were: Bill McDaniel, Brian Lund and Phil Risseeuw.

Motion by Pickett second by Gallagher that the meeting notice and agenda were properly posted. Motion carried. Motion by Pickett second by Sonsalla to approve the minutes of the previous meeting. Motion carried.

Under comments from citizens present, Brian Lund asked about the raze order on the rock house on Spring Street. Mayor Breunig asked Attorney McDaniel to respond to this question. Attorney McDaniel stated the property owner has until September 1, 2017 to respond to the raze order.

Under new business, discussion was held concerning proposed Resolution 2017-07, A Resolution to Amend Official Traffic Map of the City of Darlington. A copy of the proposed resolution was included in the agenda packet. The resolution authorizes a sign change at the intersection of Madison Street and North Street. The yield signs will be removed and replaced with stop signs to control the north and south traffic. After discussion and consideration, motion by Osterday second by Sonsalla to approve Resolution 2017-07, A Resolution to Amend Official Traffic Map of the City of Darlington as presented. By Voice Vote: Ayes: Osterday, Gallagher and Sonsalla. Nays: Pickett. Motion carried.

The July 31, 2017 financial statements for the City, Water Dept. and Sewer Dept. were then presented for review and approval. Copies of these financial statements were included in the agenda packet. After review and consideration, motion by Osterday second by Pickett to approve the July 31, 2017 financial statements for the City, Water Dept. and Sewer Dept. as presented. Motion carried.

Under reports of committees, Alderperson Sonsalla reported on the Property and Insurance Committee meeting held just prior to this Council meeting. And Mayor Breunig encouraged those present to attend the League of Wisconsin Municipalities Annual Conference scheduled for October 18th thru 20th in Appleton; and the Lafayette Development Corp. meeting on Monday, August 28, 2017 at 6:00 PM to meet the newly hired Economic Development / Tourism Director. Alderperson Pickett then stated he will contact Jeremy Williams to schedule a meeting of the Street, Public Works and Solid Waste Committee.

There being no further business for this meeting, motion by Gallagher second by Sonsalla to adjourn the meeting at 7:30 PM. Motion carried.
